## Dogs Eligible to Enter

Dogs who are at least one (1) year of age are eligible to take the ATT and must be either AKC or FSS registered or listed with Canine Partners or have a Purebred Alternative Listing (PAL) number. Dogs who are spayed or neutered may participate. Dogs with disabilities (i.e., blind, deaf, three legs) are eligible to enter provided in the opinion of the evaluator they display no signs of physical discomfort and can safely complete the test. However, if a dog has multiple disabilities such that it is unable to complete whole categories of the test (i.e., hearing auditory stimuli and also seeing visual stimuli), the dog would not earn a title.

Bitches in season are eligible to participate, they will be tested at the end. Dogs with bandages, sutures, or visible wounds are not eligible.

## Entry Fees

Each dog may be entered once in each test. **IMPORTANT:** Please contact test secretary Cindy Ronnfeldt at (602) 881-3533 prior to mailing entry to be sure that space is still available.

The Club and/or Test Secretary assumes no responsibility for incomplete or inaccurate information on the entry form, or for a dog being entered in a test for which the dog is not eligible to compete. ***Fees must accompany entries, and one entry form must be completed for each test.***

***Entries are Limited – only 25 entries per test may be accommodated.***

## Attention Exhibitors!

- **Sign in as soon as you arrive to minimize delays.**
- **Scheduling:** Exhibitors will be scheduled in 10-minute blocks. Plan on arriving at least 30 minutes before your test time. Check in when you arrive, we will do our best to accommodate scheduling change requests.
- **Crating Space:** Crating space will be available. Bring shade and water.
- **Directions to Test Site.** From central Phoenix, take Interstate 10 west to Estrella Parkway exit. Travel South to Vineyard Avenue. Turn East on Vineyard Avenue to the Estrella Mountain Regional Park entrance on the South side.
- **Notice:** The American Kennel Club Rules and Regulations will govern this event and exhibitors must make themselves familiar with the agreement on the reverse side of the official American Kennel Club Entry Form which is a part of this premium list.



## Additional Test Information

**Exhibitors are responsible for cleaning up after their dog(s).** Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor is in violation of this requirement.

**ATT Procedures.** All exhibitors should familiarize themselves with the procedure and requirements for the ATT: <https://www.akc.org/akctemptest/> and [ATT Test | AKC.tv](https://www.akc.org/akctemptest/).

**Safety, Behavior and Liability.** The safety of the dog is our primary concern. By entering this test, exhibitors acknowledge that they are familiar with the rules and regulations of the ATT, and that their dogs are familiar with and able to perform all the exercises safely. It is expressly understood that exhibitors alone are responsible for the behavior of their dogs. Any exhibitor whose dogs create an unnecessary disturbance or repeatedly engages in unsafe or disruptive behavior will be asked to leave the test site. In such cases, no refund of any fees paid will be made. The Desert Valley Doberman Club and its agents, will assume no responsibility for any loss, damage or injury sustained by exhibitors or any of their dogs or property. Desert Valley Doberman Pinscher Club reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against Desert Valley Doberman Club or any official thereof.

**Collars and Leashes.** During testing, dogs may wear slip collars that are on the dead ring, buckle collars, martingales and body harnesses. They may not wear prong collars, head collars, e-collars or harnesses that restrict the movement of the dog. Leashes should be 4 ft to 6 ft long and made of fabric or leather.

All dogs must be on leash at all times, and retractable leashes may not be used when on test grounds. Dogs must enter and exit the test area with the leash attached to the collar or harness, including when waiting in the test area before and after the test.

**Refunds.** No entry fee will be refunded if the test cannot open or be completed by reason of riots, civil disturbances, fire, and act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from the evaluation by the action of the Event Committee. Dogs pulled after closing because of injury or other medical condition are not eligible for a refund.

## Ribbons, Awards and Prizes

Exhibitors earning a qualifying ATT score (passing) will receive a ribbon.
